INSTRUCTIONS

1. Right to withdraw from the purchase contract

If you are purchasing as a consumer, you have the right to withdraw from this **purchase** contract without giving any reason within **14 days of receiving the goods**. The withdrawal period expires 14 days from the day on which you or a third party designated by you, other than the carrier, take possession of the goods, or from the day of conclusion of the contract for the provision of a service, or from the day of conclusion of the contract for the supply of digital content not supplied on a tangible medium. The withdrawal period is observed if you send the notice of exercising the right to withdraw from the **purchase** contract before the withdrawal period expires. If the subject of the purchase contract is the purchase of goods, you may withdraw from the purchase contract even before the withdrawal period starts to run.

2. Consequences of withdrawal from the contract

Following withdrawal we will refund all payments you made in connection with the conclusion of the **purchase** contract, in particular the purchase price including the costs of delivering the goods to you. This does not apply to additional costs where you chose a type of delivery other than the cheapest standard delivery we offer, nor to the costs of supplementary services where these were the subject of the contract and were provided in full. **Payments will be refunded to you** without undue delay and in any event no later than **within 14 days** from the day on which we receive your notice of withdrawal from this **purchase** contract. The refund will be made using the same means of payment you used, unless by stating the IBAN of your bank account you have consented to the refund being made to your bank account, and without charging any additional fees.

We **may withhold the refund until the goods are returned** to our address, or until you provide evidence that you have sent the goods back, whichever occurs first.

Send the goods back to us or bring them to the address of the company registered office without undue delay and in any event no later than **within 14 days from the day of exercising the right of withdrawal**. You bear the direct costs of returning the goods.

Please note that in the event of withdrawal from the purchase contract you are **liable** under the law **for any diminution in the value of the goods** resulting from handling them, in the period from their receipt until the moment of their return, in a manner other than what is necessary to establish the nature, characteristics and functioning of the goods.

If you requested the **commencement of the provision of a service** during the withdrawal period, you are obliged to **pay us the price for the performance actually provided** up to the day on which you notified us of your decision to withdraw from this contract.
